## Set Up

The following items are required from your establishment for the set up:

1. The event is from 6 to 10PM. Therefore, setup time will be between 1PM to 5PM. ONLY. (Serving time begins at 5:45 PM)
2. Your establishment must provide food sampling for at least 1000 attendees of the item(s) you list on this agreement.
3. Food must be prepared beforehand and not cooked on site (Except for Taquerias serving outdoor)
4. Your establishment must provide heating and/or cooling elements (if needed) for the food provided. IF YOU PLAN ON USING AN OPEN FLAME, PLEASE REPORT IT TO US IN ADVANCE SO THAT WE CAN GET THE PERMIT FROM THE CITY. TAKE YOUR FIRE EXTINGUISHER.
5. Plates, utensils, and paper napkins are your responsibility to provide for the attendees who will be sampling your food or sampling cups for beverages.
6. We will provide lighting and a table. You are allowed to bring a 10 x10 tent branded or unbranded, and decoration is encouraged.
7. Please bring your own extension cords.
8. Your establishment must provide servers to distribute sample items.
9. All items and decorations that are displayed must use non-damaging materials such as painters tape, string, ties straps, or 3M Command Strips. Do not nail anything into any event center walls or surfaces. All damage caused by the vendor will be the responsibility of the vendor to pay for to the City of Brownsville.
10. You must clear your area completely, remove all decoration, banners and signs, and throw away all trash before leaving your designated area. Clean up at the end of the event is the sole responsibility of your establishment.
11. Please bring mats to mitigate spills and slips
12. Additional items may be requested if required by the City of Brownsville to comply with fire safety and health regulations.
