Set Up Requirements

The following items are needed from your establishment for the set up at the event.

- 1. The event is from 5pm –9pm. Set up time will be between **1:00pm 5:00pm**. (Serving time begins at 5:00 PM)
- 2. Your establishment must provide food sampling for 500 attendees of the item(s) listed on this agreement.
- 3. Food should be prepared beforehand and not cooked on site. For anyone wanting to cook on-site, you are responsible for obtaining any applicable health permits and operating in compliance with all city ordinances and laws related to public health and safety, including fire.
- 4. Your establishment must provide heating and/or cooling elements (if needed) for the food provided.
- 5. Plates, utensils, and paper napkins are your establishment's sole responsibility to provide to the attendees.
- 6. Each sponsor is responsible for bringing their own tent or booth. Electricity will be provided on a case-by-case basis. You must provide advanced notice to Mr. Amigo of any electrical needs.
- 7. Your establishment must provide servers to distribute your sample item.
- 8. For anyone sampling inside the Market Square building, all items and decorations that are displayed must use non-damaging materials such as painters tape, string, tie straps or 3M Command Strips. **Do not nail into walls, or damage anything at Market Square.** Any damages caused by the vendor will be the responsibility of the vendor to pay for to the Brownsville Historical Association.
- You must clear your area completely, remove all decoration, banners and signs, and throw away all trash before leaving your designated area. Clean up at the end of the event is the sole responsibility of your establishment.
- 10. Location assignments are assigned by Committee
- 11. Additional items may be requested if required by Market Square.
